Contribution Increase

Congress 2024 agreed an increase of 7p per week on Grade 1 and 2p a week on Grade 2 contribution rates

These increases take effect from 1 October 2024 and will be shown in Rule 45 of the updated Rule Book which should be available on the National website from 1 July 2024.

GMB Contribution Rates from 1 October 2024

Grade 1 contributions will increase from £3.35 to **£3.42** a week or from
£14.57 to **£14.88** a month

Grade 2 contributions will increase from £1.93 to **£1.95** a week or from
£8.40 to **£8.48** a month

MPO

Former MPO members are required to pay contributions according to their remuneration but a minimum equivalent to the GMB Grade 1 rate. The revised scales are set out as follows:
